*American Sign Language- *to teach courses in ASL at the Union campus. Openings are available for the spring, summer and fall semesters.

All adjunct positions require a Master's degree in a related field and teaching experience unless otherwise indicated; candidates with an ABD, Ed.D., Ph.D. or other acceptable disciplinary doctorate are encouraged to apply. Proficiency in Blackboard and Online Learning Pedagogy is required of all adjuncts, consistent with University guidelines. Kean may offer free voluntary Blackboard workshops to otherwise qualified applicants.

Please submit cover letter (indicating availability for days, evenings or weekends), resume and contact information for three professional references. Review of applications will begin immediately and be ongoing. Official transcripts for all degrees are required before appointment.
