The Staff Psychotherapist will operate as a generalist who provides a full range of clinical services including individual and group therapy, crisis intervention, outreach and consultation. Additional duties may include supervision and training of mental health graduate students. Additionally, CAPS adheres to a short-term treatment model and we are seeking a clinician who can effectively provide time limited psychotherapy.

Essential Job Functions:

- Provides initial clinical assessment, counseling and psychotherapy, group counseling, daytime on-call coverage, crisis intervention, outreach, and consultation services to the university community.
- Maintains up-to-date case files as dictated by current professional standards.
- Adheres to ethical principles of corresponding profession.
- Facilitates psychiatric hospitalization for students as required
- May be asked to provide training and supervision to mental health graduate students
- On rare occasions after-hours or weekend outreach at major university events may be required as well.
